

RANDOM DRAW - THE MELO FASTER TOUR

Terms, Conditions & Draw Rules

ARTICLE 1: ORGANIZING COMPANY AND PURPOSE

PUMA Europe GmbH, whose registered office is located at PUMA Way1, 91074 Herzogenaurach, Germany, and which is not registered with the Trade and Companies Registry under SIRET number 803 931 690 000 17 (hereinafter referred to as the "Organizing Company"), is organizing from 05/29/2023 at 12:00 p.m. (French time) to 06/09/2023, 12:00 p.m. (French time) included, a prize draw by registration (free of charge and with no obligation to purchase) to take part in the 4 events of **"THE MELO FASTER TOUR"** on the www.themelofastertour.com website.

ARTICLE 2: PARTICIPANTS

Registration for the draw is open to all persons of legal age, with Internet access, residing in Italy, for the Milan event, taking place on 05.06.2023; in Germany, for the Berlin event, taking place on 06.06.2023; in France for the Paris event, taking place on 08.06.2023 and in England for the London event, taking place on 09.06.2023, hereinafter referred to as the Participant(s), excluding members of the staff of the Organizing Body, its partners, its corporate officers and its employees and their families, and in general all companies directly or indirectly involved in the implementation of this Game. All participants must be at least 18 years old at the time of registration, have full legal capacity and have accepted the present rules. The organizing company may ask participants to prove their age by requesting proof of identity when scanning their ticket at the entrance. The participant certifies that all information provided in the raffle is accurate. Registration for the prize draw is limited to one entry per person.

ARTICLE 3: CONSENT

- London the 09.06.2023 from 16h30 to 20h

The number of spots available in each city will depend on the legal and maximum capacity of the venues. This number will therefore be different in each city on the tour.

Each event on "**THE MELO FASTER TOUR**" will have a specific draw date.

For Milan: the draw for the first participants will take place on 02.06.23 at 12:00 (French time). Participants will have 24 hours to confirm their attendance and receive their ticket(s). After this time, and depending on the remaining places available, a second draw will take place for participants who were not drawn the 1st time. Based on this 2nd draw, the organizing company reserves the right to hold a final draw to take part in the "**THE MELO FASTER TOUR**" event, which will take place on 05.06.23 from 4.30pm to 8pm (local time).

For Berlin: the draw for the first participants will take place on 03.06.23 at 12:00 (French time). Participants will have 24 hours to confirm their attendance and receive their ticket(s). After this time, and depending on the remaining places available, a second draw will take place for participants who were not drawn the 1st time. Depending on this 2nd draw, the organizing company reserves the right to hold a final draw to take part in "**THE MELO FASTER TOUR**" event, which will take place on 06.06.23 from 4.30pm to 8pm (local time).

For Paris: the draw for the first participants will take place on 05.06.23 at 12:00 (French time). Participants will have 24 hours to confirm their attendance and receive their ticket(s). After this time, and depending on the remaining places available, a second draw will take place for participants who were not drawn the 1st time. Depending on this 2nd draw, the organizing company reserves the right to hold a final draw to take part in "**THE MELO FASTER TOUR**" event, which will take place on 08.06.23 from 4pm to 7.30pm (local time).

For London: the draw for the first participants will take place on 06.06.23 at 12:00 (French time). Participants will have 24 hours to confirm their attendance and receive their ticket(s). After this time, and depending on the remaining places available, a second draw will take place for participants who were not drawn the 1st time. Depending on this 2nd draw, the organizing company reserves the right to hold a final draw to take part in "**THE MELO FASTER TOUR**" event, which will take place on 09.06.23 from 4.30pm to 8pm (local time).

- Country

They can also register a companion of their choice by filling in the dedicated fields:

- First Name
- Last Name

All fields are mandatory to validate participation.

- Tick the box to confirm participation and accept the terms and conditions
- Tick the legal age confirmation box
- Confirm participation by clicking on the "Register" button

NB: it is not possible to participate more than once with the same address.

ARTICLE 7: LIABILITY/MAINTENANCE/EXTENSION/APPENDICES
